





MANILA CONFERENCE PREPARATIONS PROGRESSING RAPIDLY





Demonstration Trial Highlights Manila Conference

On Wednesday, October 27, 1993, the Mock Demonstration Trial, which is a mock exercise in the third party settlement of an interesting issue of public international law will commence as one of the real highlights of the Manila Conference. The participants for the trial consists of the Chief Justices of at least nine nations with one Chief Justice presiding over the trial.

The topic to be adjudicated is the "Mass Expulsion of Unwanted Minority Group by Means of Forced Deportation and the Rights and Obligations Owed by Adjoining States to the Refugees". Demonstration Chairman Ronald Greenberg, Esq. and Co-Chairman Prof. Dr. Dieter Umbach have chosen a subject that is of particular relevance given the plight of many nation-states who are confronted with this challenge throughout the international community. The following fact pattern will be utilized as the starting point for the mock trial:

For the past three years State Alpha was engaged in a bloody civil war over who would control the country as a result of a military coup. The military received substantial financial and military aid from State Zeta, while the opposition received similar aid from State Delta. The was has just ended with the military prevailing.

During the three years of fighting hundreds of thousands of men, women and children, who are citizens of State Alpha, fled their country to neighboring State Beta. Many of these refugees suffer from malnutrition and serious diseases, including AIDS. This has forced State Beta to expend millions of dollars to provide food, shelter and medical care to these refugees.

With the civil war now over in State Alpha, State Beta commences suit in the World Court against State Alpha, State Zeta and all other nations of the world. The relief sought by State Beta is as follows:

- 1. Repayment from State Alpha and State Zeta for all monies spent, and to be spent, by State Beta on the food, shelter and medical care of State Alpha's refugees.
- 2. Alternatively, repayment from all nations of the World for all monies spent, and to be spent, by State Beta on the food, shelter and medical care of State Alpha's refugees on a pro rata sharing basis, the pro rata sharing basis to be determined by the World Court.
- 3. A declaration as to whether State Beta has the right to send the refugees back to State Alpha over their objection that they will be imprisoned or killed, or to disperse the refugees to other nations of the world on a pro rata basis to be determined by the World Court.

State Alpha opposes State Beta's claims against it on the ground that it had the right under international law to its civil war, that it did not send its citizens into State Beta and that its citizens are free to return.

State Zeta opposes State Beta's claim against it on the ground that it had the right under international law to provide aid to one of State Alpha's factions and also on the ground that, if it has any responsibility for the refugee problems, so too does State Delta, since it did the same thing for the other faction.





State Delta supports State Zeta's position of no responsibility even though State Delta and State Zeta supported opposing factions.


States Alpha, Zeta and Delta all support State Beta's position that, if responsibility for the refugee problem is to be placed anywhere, it must be with all nations of the world, and that responsibility must be shared on a prorata basis to be determined by the World Court.


All other nations of the world oppose the positions of States Beta, Alpha, Zeta and Delta that they too must share responsibility for the refugee problem on a pro rata basis on the ground that they played no part in the conflict, or in the creation of the refugee problem.

It is the intent of this demonstration trial to focus attention on the world-wide refugee problem, and to begin a dialogue on finding solutions to the problem.

Workpapers For Manila Conference

The World Jurist Association has set the deadline of July 15, 1993 for the submission of workpapers to the XVI Conference on the Rule of Law in the World, to be held October 24-29, 1993 in Manila. The Association has set this deadline in order to satisfy the printing and distribution deadlines.

The Association accepts papers for publication and distribution from panelists and non-panelist. Individuals who wish to contribute work papers on current topics of worldwide interest for the Manila Conference are hereby reminded that the Association does not have facilities for typesetting or retyping. consequently, papers submitted must conform to the following regulations:

- (1) The papers should be submitted to the WJA in the original copy, not a carbon copy or photostat.
- (2) Workpapers should be typed, double spaced, on about 20 or 30 pages size 8 1/2" x 11", with the typed text covering an area about 6 1/2" x 9 1/2" or 7" x 9".
- (3) The papers presented for reproduction should look exactly the way they should in print, since what is submitted will be reproduced, in reduced size, by a photo method.

Upon approval by our Review Board the papers will be printed and distributed among the delegates in attendance at the Conference.
